Please revise your disclosure to expand upon the effect, if any, the publication of the article prior to the public announcement had on the negotiation process.

We note in recent months, as part of evaluating potential strategic alternatives, Pioneer engaged in discussions with another upstream company regarding the acquisition of that company by Pioneer. Please expand your disclosure to provide greater detail into the transaction, and the reasoning you did not progress further with

the transaction.
